Responsibilities

- Conduct field environmental monitoring activities related to air, water, waste, wildlife, soils, vegetation, meteorology, and archaeology
- Investigate, document, and write reports based on the environmental investigation.
- Work closely with site personnel to ensure compliance with the Air Quality Operating Permits, Water Pollution Control Permits, Reclamation Permits, Federal Permits, and other permits
- Maintain and contribute to improvement of sustainable systems to always ensure compliance within the organization.
- Prepare semi-annual and annual compliance reports, as assigned
- Knowledge in environmental risk identification and management, regulatory compliance systems, release reporting, environmental remediation in air, water, reclamation, etc.

- Compile and interpret data.
- Provide environmental training to on-site employees and contractors
- Responsible for periodic, after hours on-call response to environmental incidents, as needed
